THE COMMON GROUND PROGRAM IS DEDICATED TO BUILDING TRUST, BRIDGES, AND RELATIONSHIPS. WE DEVELOP CREATIVE PROGRAMS TO IMPROVE WILDLIFE MANAGEMENT, SUPPORT PRIVATE LAND STEWARDSHIP, MAINTAIN AGRICULTURE AND WORKING LANDS, AND PRESERVE OUR CULTURAL HERITAGE. IN 2020, WE GRADUATED ANOTHER 74 MASTER HUNTERS CREATING A CADRE OF 164 AMBASSADORS COMMITTED TO IMPROVING RELATIONSHIPS BETWEEN SPORTSMEN AND LANDOWNERS. IN ADDITION, OVER 40 VOLUNTEERS PROVIDED 235 HOURS OF COMBINED VOLUNTEER SERVICE FOR 8 ON-RANCH SERVICE PROJECTS. WE ALSO EXPANDED OUR WORK TO ADDRESS FOOD SUPPLY CHALLENGES CREATED BY THE SHUTDOWN OF THE MAJOR MEAT PROCESSING FACILITIES DURING COVID.

THE BLACK BUTTE COPPER MINE PROJECT WAS PART OF ONE MONTANA'S WORK TO BUILD COMMUNITY RESILIENCE AND PROVIDE GUIDANCE TO HELP COMMUNITIES PRESERVE CORE RURAL VALUES WHILE ALSO ADAPTING TO NEW ECONOMIC AND CULTURAL REALITIES. IN 2020, WE CONTINUED TO WORK WITH THE MEAGHER COUNTY STEWARDSHIP COUNCIL TO FINALIZE A COMMUNITY BENEFITS AGREEMENT AND ESTABLISHED THE COUNCIL AS ITS OWN NONPROFIT, WHICH ENDED ONE MONTANA'S INVOLVEMENT.

THE YOUTH ENTREPRENEURSHIP PROGRAM PROVIDES HIGH SCHOOL STUDENTS WITH PROJECT-BASED INITIATIVES TO HELP THEM CONSIDER VIABLE CAREER PATHWAYS, ENHANCE THEIR LIFELONG SKILLSETS, AND EMPOWER THEM TO SEE THEMSELVES AS PLAYING CRITICAL ROLES IN MONTANA'S FUTURE. IN 2020, WE PILOTED AN EDUCATION PROGRAM FOR STUDENTS OPTING FOR A GAP YEAR DURING THE PANDEMIC, PRIMARILY FROM URBAN AREAS, TO LEARN ABOUT HUNTING CULTURE AND HOW HUNTING PLAYS A ROLE IN WILDLIFE MANAGEMENT AND CONSERVATION. THE FORMAL YOUTH ENTREPRENEURSHIP PROGRAM WRAPPED UP IN 2020, BUT WE HAVE A CONTINUED COMMITMENT TO SUPPORTING YOUNG LEADERS ACROSS OUR PROGRAMS.
